### ATTACK ON IMMIGRATION UNDER TRUMP



February 24, 2020: USCIS Inadmissibility on Public Charge Grounds

June 27, 2019: Parole in Place for families of active duty and veteran military personnel will be terminated

March 19, 2019: Supreme Court upholds federal power to detain and deport immigrants for long-past crimes

**February 15, 2019:** Trump signs bill to fund parts of the government and border barrier; declares state of emergency

**January 25, 2019:** "Migration Protection Protocols" (MPP), or "Remain in Mexico" Policy

**December 20, 2018:** Department of Homeland Security announces some migrants will be sent back to Mexico to await immigration proceedings

**November 9, 2018:** Trump issues presidential proclamation preventing migrants who entered illegally from claiming asylum

October 30, 2018: Trump proposes end to birthright citizenship

**June 11, 2018:** Individuals who are victims of private crime are no longer eligible for asylum

May 7, 2018: Sessions vows to prosecute all illegal border crossers and separate children from their parents

April 2, 2018: Quotas for immigration judges - 700 per year

January 8, 2018: Terminates Temporary Protected Status (TPS) for Salvadorians

December 11, 2017: Trump calls for end to "chain migration"

November 20, 2017: Terminates Temporary Protected Status (TPS) for Haitians

November 1, 2017: Trump ends Diversity Lottery

September 27, 2017: Administration sets 45,000 refugees per year limit



## **SYNOPSIS**

Contending with the constant attack on Immigrants and Immigration Law, the lawyers on the frontlines are feeling burned out and disillusioned. This film portrays the five members of an informal support group comprised of first-generation, Mexican-American, solo-practitioners who got their start at the same high-intensity law firm in Los Angeles. Through their friendship and group chat, they provide professional, personal and emotional support as they navigate the constant attacks on their clients and profession. Through their perspectives, we see how changes in the interpretation of the laws and in legal procedures directly affect their clients by endangering their safety and prolonging family separation. After several years in the trenches, even the most dedicated come to question whether they can continue in this heartbreaking line of work.



#### THE LAWYERS

After starting their careers at the same high-intensity law firm, five immigration lawyers created an informal support group that provides professional, personal, and emotional support. While each now practices at their own firms across Los Angeles, they are in constant communication via text, email or phone.

### Alma D. Puente, Esq. El Monte, California



Seen as the "mama hen" of the group, Alma brings experience in the field and on the Border. Alma D. Puente has practiced immigration law for the last 16 years. She holds a Bachelor of Arts degree from Chapman University in English with an emphasis on Pre-Law and a Juris Doctorate from Loyola Law School. Prior to practicing law, Alma worked for the Department of Homeland Security at the Calexico Port of Entry and as an Adjudicator in Los

Angeles, California. As a first-generation Mexican-American, Alma has made it her life's work to help people navigate the complexities of immigration law in this country. Throughout her career, Alma has been dedicated to providing pro bono work for non-profits such as Kids In Need of Defense (KIND) and The Mexican American Bar Association (MABA). She has also served as a Court Appointed Special Advocate for foster children in Los Angeles County. She is a member of the Los Angeles County Bar Association (LACBA), MABA, and American Immigration Lawyers' Association (AILA). She currently serves on the board for the Immigration Resource Center of San Gabriel Valley and as a Councilwoman for the city of El Monte. Alma is married and has three sons.



### Araceli G. Guerrero, Esq. Santa Ana, California

Araceli G. Guerrero is the "greenest" lawyer and newest member of the group. Contending with constant policy and procedure changes and experiencing the most stressful time in her career, she is pushed to question whether she can continue in this line of work.

Araceli G. Guerrero practices exclusively in Immigration Law, specializing in lawful permanent residency and naturalization. She volunteers with Serve the People, providing free legal consultations, and the Hispanic Education Endowment Fund of Orange County. Araceli graduated from UCLA and Brigham Young University Law School. Her parents immigrated to the United States from Jalisco and she set up her practice in her hometown of Santa Ana.



Elizabeth P. Uribe, Esq. South Pasadena, California Elizabeth always brings the latest news and case law, as well as her calm, problem-solving demeanor to the group. Elizabeth P. Uribe was born and raised in Los Angeles to immigrant parents from Jalisco, Mexico. She is a partner at Uribe & Uribe APLC, a boutique law firm defending non-U.S. citizens in criminal and immigration proceedings, including active criminal proceedings, post-conviction relief,



Gladdys is the daughter of immigrant parents from Jalisco and Baja California, Mexico, and currently lives in Los Angeles with her husband and two daughters.

## **DIRECTOR**

Priscilla Gonzalez Sainz is a Mexican-American filmmaker based in Southern California. Her work explores themes of displacement, identity, and transnationalism that call social and political barriers into question. Priscilla earned her MFA in Documentary Film and Video from Stanford University. Her thesis film 'Room 140' portrayed accounts from asylum seeking immigrants on the night they were released from detention centers. The film was a Student Academy Award Semifinalist and received nominations for the IDA Wolper Student Documentary Achievement Award and New Filmmakers Los Angeles Best of NFMLA Awards 2019. The film

screened at various film festivals, including AFI Docs, Los Angeles Film Festival, New Orleans, and was picked up by the Atlantic Selects, KQED's Truly California strand and Vimeo Staff Pick. In 2020, Priscilla completed 'Status Pending,' a 26-minute documentary featuring five Mexican-American Immigration Lawyers who create an informal support group as they navigate the hostile world of immigration law under the Trump administration. Status Pending won the IF/Then Shorts Pitch for the American West, receiving funding and support through Tribeca Film Institute and participated in the National Association of Latino Independent Producers (NALIP) Latino Media Market. Status Pending premiered to a full house at Big Sky Documentary Film Festival in February 2020 and went on to tour the virtual circuit during the pandemic, screening as part of AFI Film Festival's Meet the Press Showcase, as well as receiving an Audience Pick Award from Palm Springs ShortFest and an Honorable Mention from Prague International Indie Film Festival. The film was picked up by Aljazeera English's Witness strand for international broadcast and Collective Eye Film educational distribution. Priscilla was recently selected for Catapult Film Fund's Research Grant to develop a new project and is one of five filmmakers participating in this inaugural fellowship. She has contributed to award winning films, including credits as an additional editor for 'Aguilas' (2021) and 'The Infiltrators' (2019). Priscilla also oversees documentary film production at Chapman University's Dodge College of Film and Media Arts and teaches at UCLA Extension.



#### **PRODUCER**

Laura Reich is an independent producer and Head of Production at Vibrant Penguin, Inc. Her work includes narrative, documentary, episodic, and branded content. In the narrative space her projects include the feature film "Kept Boy", distributed by Breaking Glass, and "All Sorts" which premiered at the 2021 Seattle International

Film Festival. In episodic television she produced the live show "The Sushi Dragon Show Starring

TheSushiDragon" on VENN TV, and post produced for the Facebook Watch Original "Rival Speak", which filmed on an XR stage, merging post with production. Her documentary work includes the PBS American Masters film "Rita Moreno: Just A Girl Who Decided To Go For It", which received theatrical distribution from Roadside Attractions after premiering at Sundance in 2021. She also produced the award-winning short documentary "Status Pending" which premiered at Big Sky Film Festival in 2020 and screened as part of NBC's Meet The Press Showcase at AFI and was picked up for international broadcast as part of the Aljazeera Witness series. Her branded work includes projects for Riot Games, The University of Southern California and LEGO.



### CO-PRODUCER

Liz Fields is an Asian-Australian-American writer and filmmaker who has traveled to 40 different countries across six continents searching for stories that illuminate human existence, struggles, and truth. After graduating from Columbia University, Liz wrote for Salon, ELLE, ABC and more before joining VICE, where she was part of the Emmy Award-winning team that launched VICE News on HBO. As a filmmaker, she's explored the insanity of the modern American

condition on the 2016 presidential campaign trail, produced a Netflix series on the global drug trade, and won a Gracie award and GLAAD nomination for her work on issues affecting minority women and the trans community.



#### IMPACT PRODUCER

Lyntoria Newton is an independent documentary filmmaker and creative producer and arts educator in the SF Bay Area. She has produced content for outlets such as The Boston Globe, PBA30, Google, The Ford Foundation, and others. Her work has shown at festivals across the U.S and internationally. She holds a B.A. from Hampshire College and an M.F.A. in Documentary Film and Video from Stanford University where she completed her thesis film, Hey Little Black Girl. The short essay film explores black

girlhood through the coming-of-age stories of four little black girls living in the SF Bay Area. With support from the Ford Foundation, she produced two seasons of *Basic Able*, a satirical podcast devoted to disrupting ableist representations of disability. She was the associate producer and engagement specialist for the feature documentary film, *River City Drumbeat*, which follows a black drum corp in Louisville, Kentucky. She also currently serves as an impact producer on the documentary film *Mossville: When Great Trees Fall*, which tells a story of environmental racism's lethal impact on a historic black community in Louisiana.



#### **FDITOR**

Sarah Garrahan is a documentary producer and editor from San Antonio, Texas. She holds a MA in Creative Documentary from the Autonomous University of Barcelona and a MFA from Duke University in the Experimental and Documentary Arts. She was a coproducer and additional editor on the hybrid documentary *The Infiltrators* by Cristina Ibarra and Alex

Rivera, which premiered at the Sundance Film Festival in 2019 and was awarded both the Audience and Innovator Awards for the NEXT section. She was an editor on *Building the American Dream* by Chelsea Hernandez, which premiered at SXSW in 2019. She is currently editing Jasmin López's the feature documentary, *Silent Beauty*.
